ORDER:

In the G.O. 1st read above, Government have approved the list of Backward Classes (other than Scheduled castes and Scheduled Tribes) and declared that the castes and Communities specified in Annexure-I to the said order are Socially and Educationally Backward Classes for the purposes of Article 15(4) and 16(4) of the Constitution of India.

2. The General Secretary, Andhra Pradesh Are Marathi Sangh, Narsaraopet and the Secretary, Surabhi Nataka Kala Sangham, Hyderabad submitted representations requesting to include Are Marathi, Maratha (Non-Brahmins), Arakalies, and Surabhi Natakavallu in the list of Backward Classes.

3. In the reference 2nd read above, the Chairman, A.P.Commission for Backward Classes, Hyderabad has submitted a report, recommending that "Are Marathi, Maratha (Non-Brahmins), Arakalies, and Surabhi Natakavallu" caste are socially and educationally backward for the purpose of Article 15(4) & 16(4) of the Constitution of India and fit to be included in the list of Backward Classes under Group-B at Serial No.25.

4. The Government, after careful examination of the matter, have decided to accept the above recommendation of the A.P.Commission for Backward Classes.

5. Accordingly, Government hereby order that the caste "Are Marathi, Maratha (Non-Brahmins), Arakalies, and Surabhi Natakavallu" be included in the list of Backward Classes under Group-B at Serial No.25 for the purpose of Articles 15(4) and 16(4) of the Constitution of India.

6. The Director, Backward Classes Welfare, Hyderabad and all the District Collectors are hereby directed to take necessary action accordingly.
